GENERAL RESPONSIBILITIES

- 1. Perform laundry room procedures in an efficient manner.
- 2. Maintain cleanliness and organization of laundry room.
- 3. Wash, dry, & fold assorted laundry, to include linens, towels, and washcloths.
- 4. Keep all laundry in good condition; sew, mend, & repair when necessary.
- 5. Maintain control of supplies; notify housekeeping manager when necessary to order supplies.
- 6. Work in harmony with other staff who may be assigned to laundry room.
- 7. Drive golf cart or truck in safe manner.
- 8. Work efficiently, cheerfully, and in harmony with other staff.
- 9. Perform functions of Room Attendant when necessary.
- 10. This position requires regular and predictable attendance as an essential function of the job.

NON-ESSENTIAL JOB FUNCTIONS

- 1. Perform other work-related duties as assigned by supervisor.
- 2. Regular and temporary full-time employees may be temporarily assigned to work in another department to complete a full work (40 hour) week if work demands require.

QUALIFICATION STANDARDS

- 1. Ability to understand and follow directions given.
- 2. Ability to work independently and with little or no supervision.
- 3. Ability to observe needs and respond quickly and independently.
- 4. Ability to provide good supervision of others.
- 5. Proficiency as a seamstress for mending/repairing linens, bath towels, draperies, and other laundry items.

Education

- 1. Any combination of education and experience equivalent to graduation from high school or any other combination of education, training, or experience of at least one year that provides the required knowledge, skills and abilities necessary to perform the duties of the position.
- 2. Minimum of 8th grade education, high school diploma or GED preferred.
- 3. It is preferred that applicants speak or understand the English language to the degree that communication of their job duties, job scheduling, safety standards and health standards are understood.

Experience

Previous housekeeping experience in a commercial setting preferred.

Grooming & Uniform

All employees must maintain a neat, clean and well-groomed appearance. Distinctive dress (uniform) must be worn at all times while on duty.

Physical

Requires grasping, writing, standing, sitting, walking, repetitive motions, hearing, visual acuity, and good speaking skills. Must be able to squat, bend, kneel, climb, and reach. Ability to push, pull, and carry a minimum of thirty (30) pounds.

Work Schedule

Must be available to work weekends and holidays, and be flexible with working hours.

Personal

- 1. Must have good moral character and high degree of honesty, trustworthiness, and integrity.
- 2. Possess and demonstrate a positive attitude to guests, supervisors, peers, and fellow employees.
- 3. Ability to safely and efficiently use appropriate chemicals.
- 4. Good driving record, able to meet the driving requirements set forth by the insurance carrier.
