Youth Conference Sponsor Background Checks

Each sponsor is required to have a background check on file before arriving at Mo-Ranch. Every background check must have been run within 12 months of the conference and include social security number verification, a criminal super search (includes Nationwide Sex Offender Registry search) and a terrorist search. In addition, each adult sponsor is required to complete a training for Abuse Awareness.

To complete these requirements:

- 1. Please provide the legal name and e-mail address for each sponsor expected to attend. (see below)
 - Mo-Ranch Program staff will enter this information into Ministry Safe.
 - Ministry Safe will then send a link for the training videos to the sponsor. (The training can be completed in segments.)
 - At the end of the training, a test will be given.
 - Upon completion, Ministry Safe will notify Mo-Ranch Programs of the completion of this training.
- 2. Provide verification of cleared background check for each adult sponsor.

- If you have a completed background check which complies with all of the criteria listed in the first paragraph above:
 - Submit your results by fax to the Mo-Ranch Program Office (830-238-4014).
 - Our Human Resources department will verify compliance.
 - We will provide necessary updates to the contact person below.
- As an alternative, Mo-Ranch is able to complete the background check for each sponsor.
 - Please include a \$14 non-refundable fee per background check.

"Sexual Misconduct is the comprehensive term used in this policy and its procedures to include: 1) Child sexual abuse, as defined above [refers to Policy]; 2) Sexual harassment, as defined above [refers to Policy]; 3) Rape or sexual contact by force, threat, or intimidation; 4) Sexual conduct (such as offensive, obscene or suggestive language or behavior, unacceptable visual contact, unwelcome touching or fondling) that is injurious to the physical or emotional health of another; 5) Sexual Malfeasance defined as sexual conduct within a ministerial (e.g. clergy with a member of the congregation) or professional relationship (e.g. counselor with a client, lay employee with a church member, presbytery executive with a committee member who may be a layperson, a minister, or an elder). Sexual misconduct includes unwelcome sexual advances, request for sexual favors, and verbal or physical conduct or contact of a sexual nature. This definition is not meant to cover relationships between spouses, nor is it meant to restrict church professionals from having normal, social, intimate, or marital relationships; 6) Sexual Abuse as found in the Book or Order D-10.0401b (see Accuser/Victim). Sexual Misconduct also includes but is not limited to any arrest, indictment or conviction for criminal homicide; aggravated assault; crimes related to possession, use, or sale of drugs or controlled substances; sexual abuse; sexual assault; injury to a child; incest; indecency with a child; inducing sexual conduct or sexual performance of a child; possession or promotion of child pornography; the sale distribution or display of harmful material to a minor; employment harmful to children; abandonment or endangerment of a child; kidnapping or unlawful restraint; public lewdness or indecent exposure; and enticing a child. Sexual Misconduct also includes but is not limited to the following specific acts or omissions, Any direct observations or evidence of sexual activity in the presence of or in association with a minor, any display or demonstration of sexual activity, abuse, insinuation of abuse, or evidence of abusive conduct towards a minor, sexual advances or sexual activity of any kind between any person and a minor, infliction or physically abusive behavior or bodily injury to a minor, physical neglect of a minor, including failure to provide adequate supervision in relation to activities, mental or emotional injury to a minor, the possession or presentation of obscene or pornographic materials to a minor, the presence, possession, or being under the influence of any illegal or illicit drugs with or in the presence of a minor, the consumption of or being under the influence of illegal or illicit drugs or alcohol while leading or participating in a function for minors and providing alcohol or drugs to a minor unless otherwise allowed by law.

Youth Conference Sponsor Responsibilities

The mission of Presbyterian Mo-Ranch Assembly is to foster growth in God through Jesus Christ by sharing its unique living, learning, Christian environment.

Adult sponsors play a key role in the success of each of our conferences.

- Each group must send a minimum of one adult for every five youth. Churches must send sponsors of the same gender as those youth who will be participating.
- In order to maintain a ratio, adult sponsors may be asked to supervise youth from another congregation up to a
 maximum of five youth. Confirmation of registration is dependent on the availability of sufficient adult sponsors for
 each gender and/or the gender requirement.
- Churches with small congregations that find it difficult to meet the sponsor/participant ratio should contact the Mo-Ranch Program Office (programs@moranch.com) for assistance in securing appropriate supervision for their youth.
- Mo-Ranch has a zero-tolerance policy regarding child abuse (including, but not limited to physical, emotional or sexual abuse).
- Mo-Ranch sponsors must also abide by the Rule of Three (2 youth and 1 adult) or (2 unrelated adults and 1 youth) to ensure safety for all guests. No adult shall be left alone with a minor; therefore, sponsors will not be housed in the same hotel room as youth participants. A reasonable ratio of adult workers will be maintained in each situation involving the supervision of minors.
- Mo-Ranch staff and volunteer directors will engage in ongoing supervision and may make unannounced visits to classes and other program sites during the conference.
- Sponsors are responsible for the behavior of their youth at all times.
- Sponsors are asked not to bring non-participant children to the conference.
- Each sponsor is expected to participate fully in all conference activities and to facilitate home group devotions.
- Sponsors are responsible for ensuring that their youth attend all conference activities.
- Sponsors are expected to maintain a positive attitude because it will make a difference in the atmosphere of the conference. Your attitude has a direct effect on your youth and on your own enjoyment. You are an important role model!
- Sponsors are expected to see that youth observe afternoon rest times and lights-out each night, eat regularly, drink plenty of water, and remember to use sunscreen.
- Sponsors are not allowed to leave Mo-Ranch once your group has checked-in (unless for emergencies).
- In the case where a youth participant becomes ill/injured and requires medical attention, youth sponsors are the designated responsible adult(s) to transport/accompany the young person to the clinic or hospital. Mo-Ranch staff and/or conference leadership will provide guidance and assistance with the young person's situation (e.g. responding with First Aid, providing directions to urgent care or the ER, etc.), but youth sponsors remain the primary care-giver for the youth.
- Sponsors are encouraged to be open to all the good ways God is at work in the conference community.

Youth Conference Participant Covenant

The mission of Presbyterian Mo-Ranch Assembly is to foster growth in God through Jesus Christ by sharing its unique living, learning, Christian environment.

More than a set of "rules" or "guidelines" a covenant between conference participants remembers our Biblical foundations. God who created all that was, is, and is to come made covenant to love and care for us at all times. Following God's lead, we covenant with one another when we gather in community in order to make a safe and caring place for playing, studying, worshiping and living.

I promise to participate in the building and caring for community by:

- Being fully present and participating in all scheduled activities
- Showing respect for conference participants, staff, other guests as well as the ranch itself by:
 - O Asking before entering a housing facility that is not my "home" for the week
 - o Abiding by the smoke-free building policy
 - o Being responsible for my belongings and caring for the property of others
 - o Refraining from throwing things off either catwalk
 - o Swimming in groups, at designated times
 - o Refraining from jumping or diving from the highway bridge or the dam
 - o Using the Ropes Course only while Mo-Ranch staff are present
- Dressing appropriately by wearing clothing that allows me to participate fully in the activity at hand, keeping in mind that I am attending a church youth conference and that I represent my family, congregation and community at all times by what I say, do, and wear. I will not bring clothing that advertises alcohol or tobacco or other illegal substances; nor which contain language/pictures that demean or ridicule someone's gender, sexuality or ethnic origin.
 - O Swim suits must fit in such a way that they stay on my body. Swim trunks should be worn at the waistline and not be shorter than mid-length (6"-7" inseam).
 - O Water activities/recreation events: All participants are expected to wear t-shirts covering the torso/with sides.
- Abiding by laws prohibiting the possession or use of illegal drugs and which prohibit the possession or use of alcoholby persons under the age of 21. (As an adult over the age of 21, I will abstain from consuming alcohol during the conference). I will take medication prescribed to me by a doctor only as directed.
- Refraining from sexual activity while at Mo-Ranch.
